## 3<sup>RD</sup> INTERIM CREDIT RELEASE

Reference is made to your letter dated March 9, 2018, requesting the release of compensatory mitigation credits (credits) generated at the Sand Hill Lakes Mitigation Bank (SHLMB). The Mitigation Banking Instrument (MBI) for the SHLMB was approved by the U.S. Army Corps of Engineers (Corps) on May 16, 2006. The SHLMB was approved to provide compensatory mitigation for impacts to waters of the United States for those activities located within the SHLMB service area which have been authorized by Department of the Army (DA) permits. The 2,155-acre SHLMB is located in Washington County, Florida west of the intersection of State Road (SR) 77 and SR 279 within Sections 1, 11, and 12 of Township 1 north, Range 15 west; Sections 5-8, and 17 of Township 1 north, Range 14 west; Section 36 of Township 2 north, Range 15 west; and Section 31 of Township 2 north, Range 14 west, north of Panama City, Florida. The SHLMB project has been assigned file number SAJ-2002-05061. Please reference this number in any future correspondence.

Credits generated at SHLMB were determined through the application of the Wetland Rapid Assessment Procedure (WRAP). Credits currently listed as palustrine forested credits were originally identified in the MBI as either hydric flatwoods wetlands or mixed hardwood wetlands; credits currently identified as palustrine emergent were originally identified in the MBI as herbaceous wetland credits. As established, SHLMB has the potential to generate a maximum of 284.03 federal credits, classified as 256.23 Palustrine Forested (hydric flatwoods, mixed hardwood) and 27.80 Palustrine Emergent (herbaceous) WRAP credits. Interim credits are eligible to be released for successfully meeting specific performance or success criteria in accordance with the success criteria found the MBI and detailed in your 2017 monitoring report and credit release request.

The Corps, in consultation with other members of the federal Interagency Review Team (IRT), has evaluated your request for the third interim release of credits as described in the Credit Release Schedule. The release of these credits is associated

with the achievement of interim success criteria specified for each of the 14 management units within the Management Plan of the MBI.

After receipt of the 2017 monitoring report and request for credit release, IRT agencies visited the SHLMB site on March 28, 2018 to evaluate the condition of the site following recent winter fire management. In addition to reviewing the 2017 monitoring report and current site conditions, the IRT reviewed previous baseline and annual monitoring reports. While reviewing the site, stewardship staff from the Florida Fish and Wildlife Conservation Commission discussed the need for additional structures within the already-developed storage and administration area near the entrance and for additional portable restroom facilities at a remote lake parking area. The additional structures would be used for equipment storage by regional law enforcement staff and would have a side benefit of increasing enforcement presence on and near the bank site. The additional portable restrooms would curb potential overflow from the remote lake parking areas. The IRT concurred that both requests were desirable, and would be improvements to long-term stewardship as well as promoting the ecological success of the site.

In summary, based on the March 28, 2018 IRT site inspection and review of baseline and annual monitoring reports submitted, the Corps has determined that all relevant success criteria for the third interim credit release have been attained in accordance with the provisions noted in the MBI. Therefore, **25.62 Palustrine Forested** and **2.78 Palustrine Emergent credits** are now released and available for sale by the SHLMB to provide compensatory mitigation for impacts to waters of the United States authorized by DA permits.

This is the seventh overall credit release the Corps has approved for SHLMB and the third based on performance of the site. To date, including this action, the Corps has released a total of **195.63 Palustrine Forested and 17.48 Palustrine Emergent credits** to SHLMB. While you will be maintaining a ledger for the SHLMB as required by the regulations at 33 CFR 332.8(p)(1), the Corps will be utilizing the Regulatory In-Lieu Fee and Bank Information Tracking System (RIBITS) to track credit accounting for the SHLMB. As the Sponsor for the SHLMB, you are required to provide the Corps with notification of all approved credit transactions.
