Thank you very much for your review and for forwarding the Department's approval of the District's 2019 Regional Mitigation Plan for FDOT projects.

As I mentioned in my earlier email, FDOT has proposed two additional projects for mitigation through the District's program per section 373.4137, F.S. These projects were added to the project inventory subsequent to the development of the 2019 plan to meet unanticipated mitigation needs based on regulatory direction from the U.S. Army Corps of Engineers.
