RE: Sand Hill Lake Mitigation Bank Permit No. 227351-023, Washington County

Your request to debit the above referenced permit's ledger has been received, reviewed and approved by Department staff. By copy of this letter and the attached ledger we are notifying all necessary parties of the modification.

A person whose substantial interests are affected by the Department's action may petition for an administrative proceeding (hearing) in accordance with Section 120.57, Florida Statutes (F.S.). The petition must contain the information set forth below and must be filed (received) in the Office of General Counsel of the Department at 3900 Commonwealth Boulevard, Tallahassee, Florida 32399-3000. Petitions filed by the permittee and the parties listed below must be filed within 21 days of receipt of this letter. Petitioner shall mail a copy of the petition to the permittee at the address indicated above at the time of filing. Failure to file a petition within this time period shall constitute a waiver of any right such person may have to request an administrative determination (hearing) under Section 120.57, F.S.

The Petition shall contain the following information:

- (a) The name, address, and telephone number of each petitioner, the permittee's name and address, the Department Permit File Number and the county in which the project is proposed;
- (b) A statement of how and when each petitioner's received notice of the Department's action or proposed action;
- (c) A statement of how each petitioner's substantial interests are affected by the Department's action; or proposed action;

- (d) A statement of the material facts disputed by petitioner, if any;
- (e) A statement of facts which petitioner contends warrant reversal or modification of the Department's action or proposed action;
- (f) A statement of which rules or statutes petitioner contends require reversal or modification of the Department's action or proposed action; and
- (g) A statement of the relief sought by petitioner, stating precisely the action petitioner wants the Department to take with respect to the Department's action or proposed action.

If a petition is filed, the administrative hearing process is designed to formulate agency action. Accordingly, the Department's final action may be different from the position taken by it in this letter. Persons whose substantial interests will be affected by any decision of the Department with regard to the permit have the right to petition to become a party to the proceeding. The petition must conform to the requirements specified above and be filed (received) within 21 days of receipt of this notice in the Office of General Counsel at the above address of the Department. Failure to petition within the allowed time frame constitutes a waiver of any right such person has to request a hearing under Section 120.57, F.S., and to participate as a party to this proceeding. Any subsequent intervention will only be at the approval of the presiding officer upon motion filed pursuant to Rule 28-5.207, F.A.C.

This Notice constitutes final agency action unless a petition is filed in accordance with the above paragraphs or unless a request for extension of time in which to file a petition is filed within the time specified for filing a petition. Upon timely filing of a petition or a request for an extension of time this Notice will not be effective until further Order of the Department.

Any party to this letter has the right to seek judicial review of the Order pursuant to Section 120.68, Florida Statutes, by the filing of a Notice of Appeal pursuant to Rule 9.110, Florida Rules of Appellate Procedure, with the Clerk of the Department in the Office of General Counsel, 3900 Commonwealth Boulevard, Tallahassee, Florida 32399-3000; and by filing a copy with the appropriate District Court of Appeal. The Notice of Appeal must be filed within 30 days from the date the Notice of Permit Modification is filed with the Clerk of the Department.

The Sand Hill Lakes Mitigation Bank (FDEP Permit 0227351-001) has a current state Credit Ledger balance of 107.84 UMAM Credits (6.29 Freshwater Herbaceous, 57.88 Freshwater Forested Flatwoods, and 43.67 Freshwater Mixed Hardwoods).

A PERMIT AUTHORIZING:

The construction of a surface water management system to serve the widening of approximately 5.6 miles of rural State Road 77 from the Bay County line to County Road 279, in Washington County. State Road 77 is currently a two-lane undivided rural roadway which will be widened to a four-lane divided rural roadway equipped with curb and gutter collection system, roadside conveyance swales, and multiple stormwater management ponds designed to provide treatment and attenuation for the approximately 695-acre overall drainage area. The project consists of seven, hydraulically separate, drainage basins which have been further broken down to multiple sub-basins. There is a 6.09-acre drainage basin (Basin SOUTH) that has been previously accounted for in the adjacent roadway segment and is directed to Pond #7 that is an existing pond that was authorized under an FDEP permit prior to ERP, and there is an 8.99-acre drainage basin (Basin NORTH) that has been previously accounted for in the adjacent roadway segment and is directed to SWF 2 under IND-133-17232-1. A description of the drainage basins and the systems that serve each are as follows: Basin 1 is served by Pond 1D and Pond 1 which have been designed as dry retention ponds; Basin 2 is served by Pond 2 which has been designed as a dry retention pond; Basin 3 is served by Pond 3 which has been designed as a dry retention pond; Basin 4 is served by Pond 4A, Pond 4B, Pond 4C, and Pond 4D where Pond 4A, Pond 4C, and Pond 4D have been designed as dry retention ponds and Pond 4B has been designed as a wet detention pond; and, Basin 5 is served by Pond 5 which has been designed as a dry retention pond. Each of the ponds have been designed to either retain up to the 100year / 24-hour storm event or discharge offsite where the area historically drains. Direct wetland impacts totaling 0.903 acres in wetlands and 0.178 acres in other surface water ditches, and 0.393 acres of secondary impacts are authorized. Mitigation for wetland impacts will be through purchase of 0,485 freshwater forested mitigation credits at Sand Hill Lakes Mitigation Bank. The surface water management system is in accordance with the approved plans and supporting drainage report prepared by HDR Engineering, Inc.
