Question 1: If our Managing General Agent fulfills this requirement, will we as the independent agent also have to meet this minimum below requirement?

> The question on item 6 for 3.1 Proposal requirements: Up to five client references with contact name, address, phone, and email that are similar in organization size, public sector-related, and coverages (the District cannot be included as a reference).

References are required by the company identified by the Respondent in Exhibits A and B. Answer:

Question 2: How do we get access to the prior year's historical premiums for this proposal?

Answer: A one-page summary of paid premium invoice amounts for policy year 2021 is **Attachment**

1 on the FTP site. The amounts differ slightly from the premiums in the policy effective

October 1, 2020, due to updates made to District assets listed and values.

Question 3: Please provide the following additional information:

- Detailed Package Loss Runs, showing a breakout of payment on each claim, both open and closed.
- Workers Comp Experience Mod.
- Expiring policy showing all coverages and requested in this RFP, including expiring premiums.

Answer:

Regarding loss runs, RFP Exhibits G and H show a breakout of payments for each claim, both open and closed since policy year 2016. The District obtained the latest reports and are in **Attachments 2 and 3** on the FTP site.

Regarding workers compensation, the National Council on Compensation Insurance, Inc., calculation of the District's workers compensation experience rating is in <u>Attachment 4</u> on the FTP site.

The complete annual policy and premiums effective as of October 1, 2020, are in <u>Attachment</u> 5 on the FTP site. The latest premium payments for policy year 2021 can be found in the one-page summary provided in the response to Question 2.

Question 4: Could you please provide the declarations page for the current coverage?

Answer: Declaration pages are included in the complete annual policy provided in the response to Question 3.

Question 5: What is the 2021-2022 Worker's Compensation Experience Modification Factor that we should use for quoting?

Answer: This factor is addressed in the response to Question 3.

Question 6: On the 3.3 Vendor Checklist it states to make sure proposers have included a "statement of disclosure." Is there a form to complete or are we to simply include a statement confirming as such? If a conflict does not exist at all, does a statement need to be included stating as such?

Answer: The District does not have a template form. The Respondent is to include a statement of disclosure **ONLY** if a conflict of interest described in SECTION 1.20 exists. The statement of disclosure must contain the information required by SECTION 1.20.
