Training, support, and hosting will consist of the following:

Training: Conduct a combination of training actions, including phone, web conferences, and on-site sessions, to support ongoing training needs of forest management staff and other District personnel who use the forest management software and data collectors.

Support: Provide phone, web meeting, and on-site support when requested by District staff. This support includes help on "how to" do a task, fixing any data issues, and any other requested support/training requests.

Hosting: Annual hosting includes the following:

- ArcGIS Server 10.7 or higher – for deployment of map and feature services for web maps. Hosted on Azure D2\_V2 Standard Server (2 cores/7GB);
- ArcGIS Online – for deployment of web maps and apps;
- ArcSDE geodatabase housed in Microsoft SQL Azure – S3 Elastic Pool (100 DTU's);
- Microsoft Office 365 SharePoint online – for app, report, document and map repository as well as application issue tracking;
- Microsoft Excel Power Pivot/Power View/Web Access for inventory and event reports;
- Microsoft Azure App Service – Web Apps – for deployment of event manager web application;
- 1.5 hours per month for general application, services and database maintenance.

The District currently utilizes the F4-Tech SilvAssist proprietary software for timber management and houses its forest inventory data through F4-Tech. Growth and yield models utilize F4 Tech's SilviAssist software to integrate into the USFS's FVS. This data and software will be used for strategic forest planning and model results that need to be delivered via the District's existing timber management tool - F4 Tech's proprietary SilvAssist Forest Information Dashboard.
