Dear Ms. Tauxe,

Please accept this submittal as the second progress report for the SHLMB. Little additional work has occurred at the bank since the last progress report. However, all additional work completed as well as problems and potential solutions are described below.

Please provide a brief description of permit requirements met and extent of work completed the previous report or since the permit was issued:


Figure 10a - Road Improvements

- 1. Road work was initiated on the main loop from the entrance to Deep Edge Pond and eastward to Dykes Mill Pond and Greenhead Branch, and from Greenhead Branch back to the entrance road (Figure 10a). The roadwork was initiated on April 24<sup>th</sup> and is expected to continue until the end of May. The road will be capped with clay and lime rock. This will allow the heavy earth moving equipment and logging trucks to traverse the road during the construction and harvesting activities. The areas used as "turn arounds" for the clay and rock trucks will be re-planted with wire grass plugs once the work has been completed. The road work is also discussed in the May inspection report.
- 2. In accordance with Attachment H Monitoring plan, the photographic stations have been installed. Spring pedestrian surveys are ongoing.
- 3. Continued surveys for feral hogs revealed a small herd of feral hogs on the northeast side of Dry pond and adjacent to the Green Ponds. The Florida Fish and Wildlife Commission estimated a population of one boar, two sows and their offspring. A special use take permit was issued to John Dunlap on May 12, 2006 to remove the hogs and copy of the letter from the Florida Fish and Wildlife

- Conservation Commission has been included in the submittal. To date one female hog approximately 80 pounds and pregnant has been trapped (See attached memos and Figure 10b).
- 4. During the May site inspection, torpedo grass (*Panicum repens*) was observed adjacent to the boat ramps of two of the green ponds (Figure 10b). Current coverage is minimal at each of the boat ramps (Inspection Form Included in Submittal). It appears that the torpedo grass has been there for many years. A detailed inspection of the green ponds will be conducted the week of May 22<sup>nd</sup> to determine if there is any additional torpedo grass cover. Following the inspection, a contract will be issued to a certified aquatic herbicide applicator to treat the population.
- 5. In accordance with Specific Condition 8, an annual Law Enforcement Report has been included in the submittal (Figure 11).

#### Restoration activities anticipated within the next 6 months:

- 1. In accordance with Specific Condition 10, turkey and live oaks will be reduced to 150 trees or less in portions of Management Unit 10.
- 2. In accordance with Specific Condition 11 and Attachment E, warm season burns will occur at the SHLMB over the summer. Updated burn maps will be included in subsequent progress reports and or the annual report.
- 3. In accordance with Specific condition 12, hydrologic improvements are expected to be implemented in the next 6 months.
- 4. In accordance with Attachment H: Monitoring and Maintenance, an aerial photo of the site will be taken to provide an aerial view of the status of the restoration and vegetation.

# Please provide copies of the permit drawings indicating areas where work has been completed:

To date no earth moving activities have been initiated at the bank. Work is expected to start within the next month. DHR's was called on 5/23/2006 to determine the status of the review of the historical report. The review is expected to be completed within the next week.

## Please provide a brief description of problems encountered and solutions undertaken:

Since the last progress report, there have been no substantial problems encountered at the SHLMB.



The officers informed these individuals about the problems associated with riding in sensitive areas and verbally warned them a bout the restrictions on horseback riding.
