The Review Team (RT) meeting was held Friday, January 30, 2015 (10 AM – 12 PM EST) at the FDOT District-3 Midway Maintenance Office (17 Commerce Blvd. at the US 90 / I-10 interchange west of Tallahassee).

- USACE approval of the NWFWMD ILF Program is imminent. This program will provide options to FDOT when private mitigation banks are not available.
- The Umbrella Plan will continue to operate on the state side, and will parallel the federal ILF program.
- Non-ILF mitigation (i.e., permittee-responsible mitigation for federal and state permits) will continue under the Umbrella Plan where FDOT is unable to make use of private mitigation banks or the ILF program. FDOT will hold mitigation permits, although NWFWMD is responsible for mitigation per Florida Statutes.
- Updates on various NWFWMD mitigation projects (ILF project sites and the Sand Hill Lakes Mitigation Bank) were presented.
- The FDOT, USFWS and the USACE presented awards of appreciation to Duncan, who is retiring February 2, 2015.

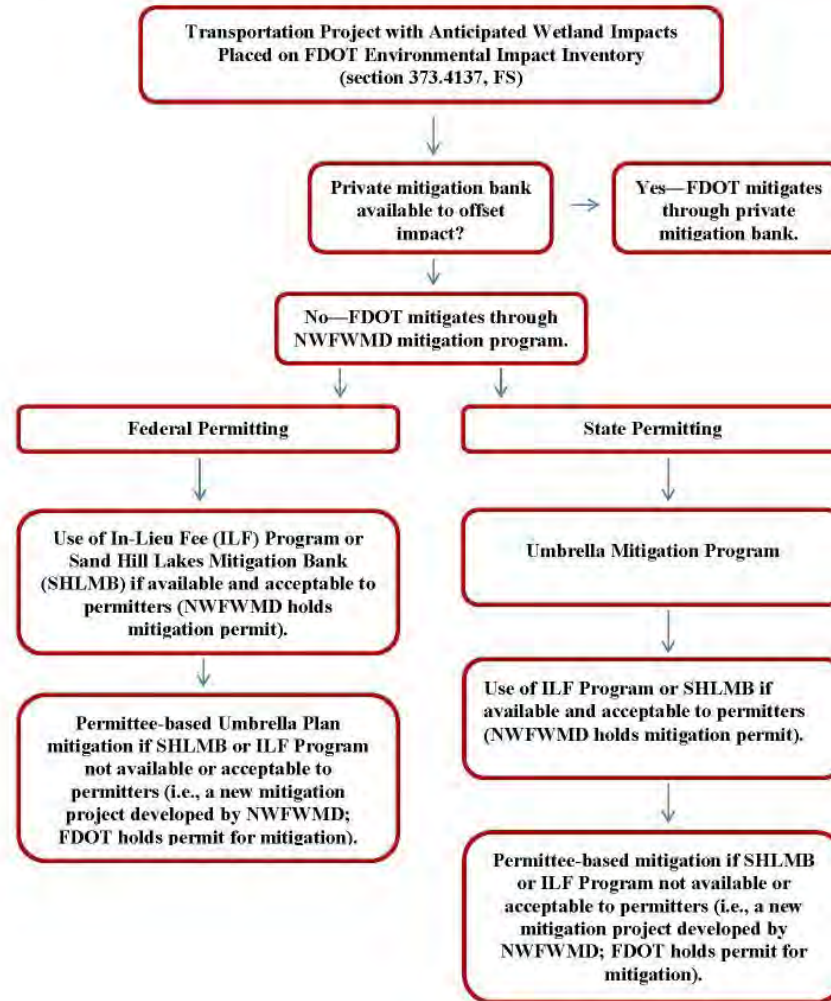
Status of In-Lieu Fee Program and Umbrella Plan

- Approval of Final ILF Instrument imminent.
- 195.98 credits released under Umbrella Plan will transition to the federal ILF Program and be available for immediate use.
- An additional 159.38 credits may be released under the federal ILF Program as success criteria are met.

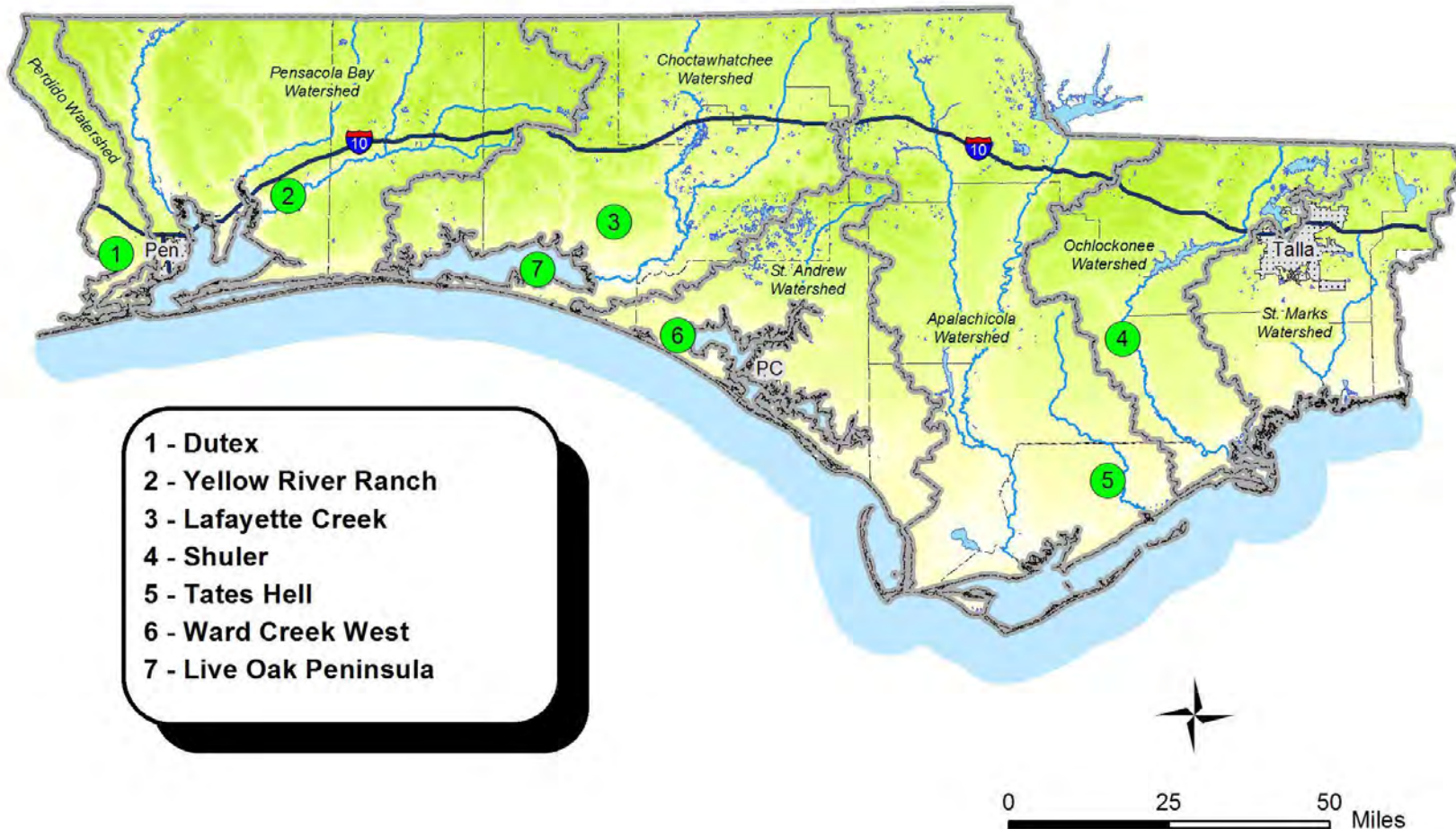
Status of In-Lieu Fee Program and Umbrella Plan (Continued)

- A non-federal “Umbrella Plan” program will continue to operate and parallel the federal ILF program.
- Debits for federal permits will be recorded on both the ILF federal credit ledger and the Umbrella Plan credit ledger, whereas debits for state permits will be recorded only on the Umbrella Plan credit ledger.
- Non-ILF mitigation (i.e., permittee-responsible mitigation for federal and state permits) will continue under the Umbrella Plan.
- Although we loosely use the term “umbrella plan” to refer to everything, in the context of the above, the Sand Hill Lakes Mitigation Bank is a third rail and separate from the Umbrella Plan.

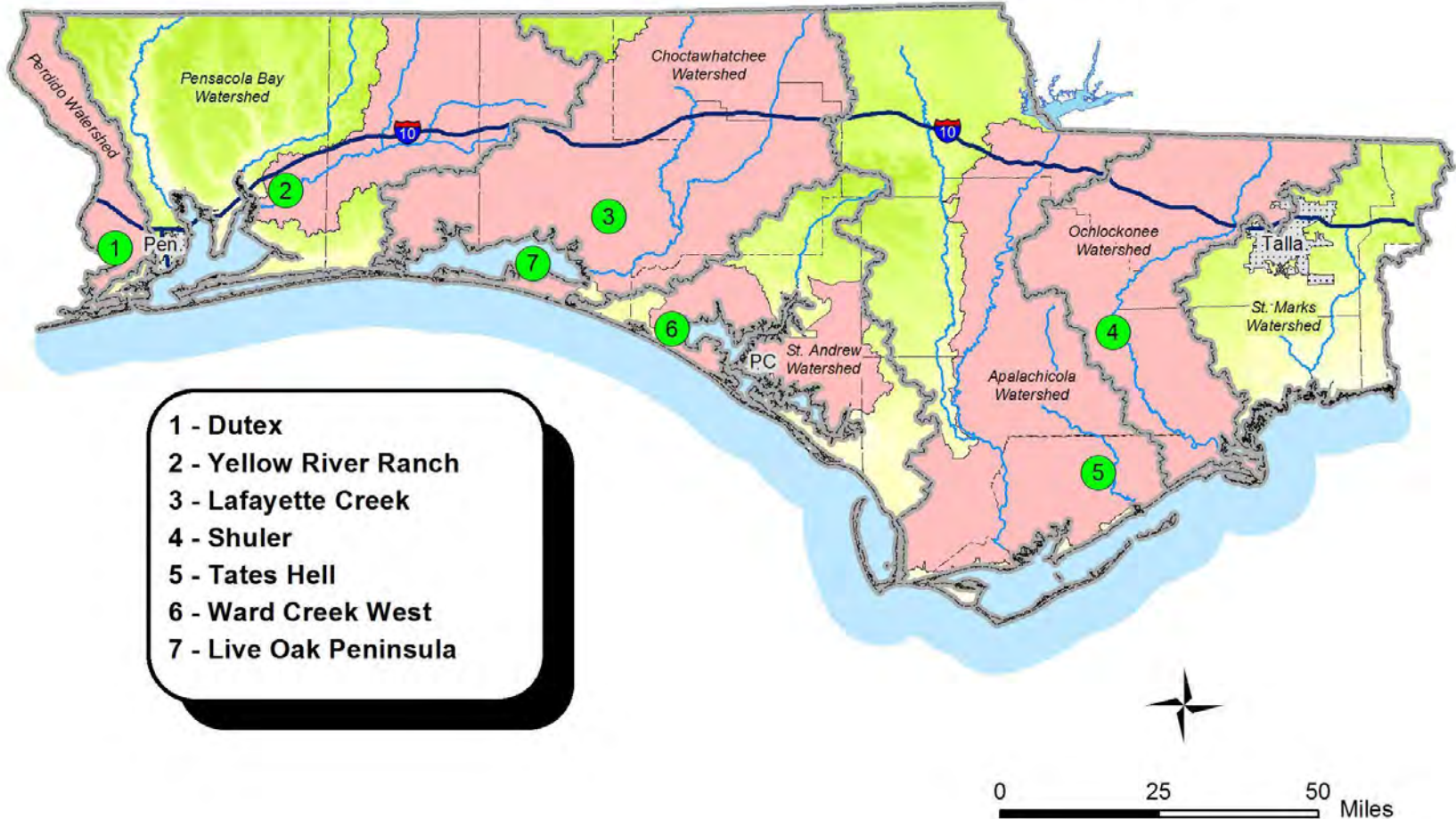
FDOT Compensatory Mitigation Process



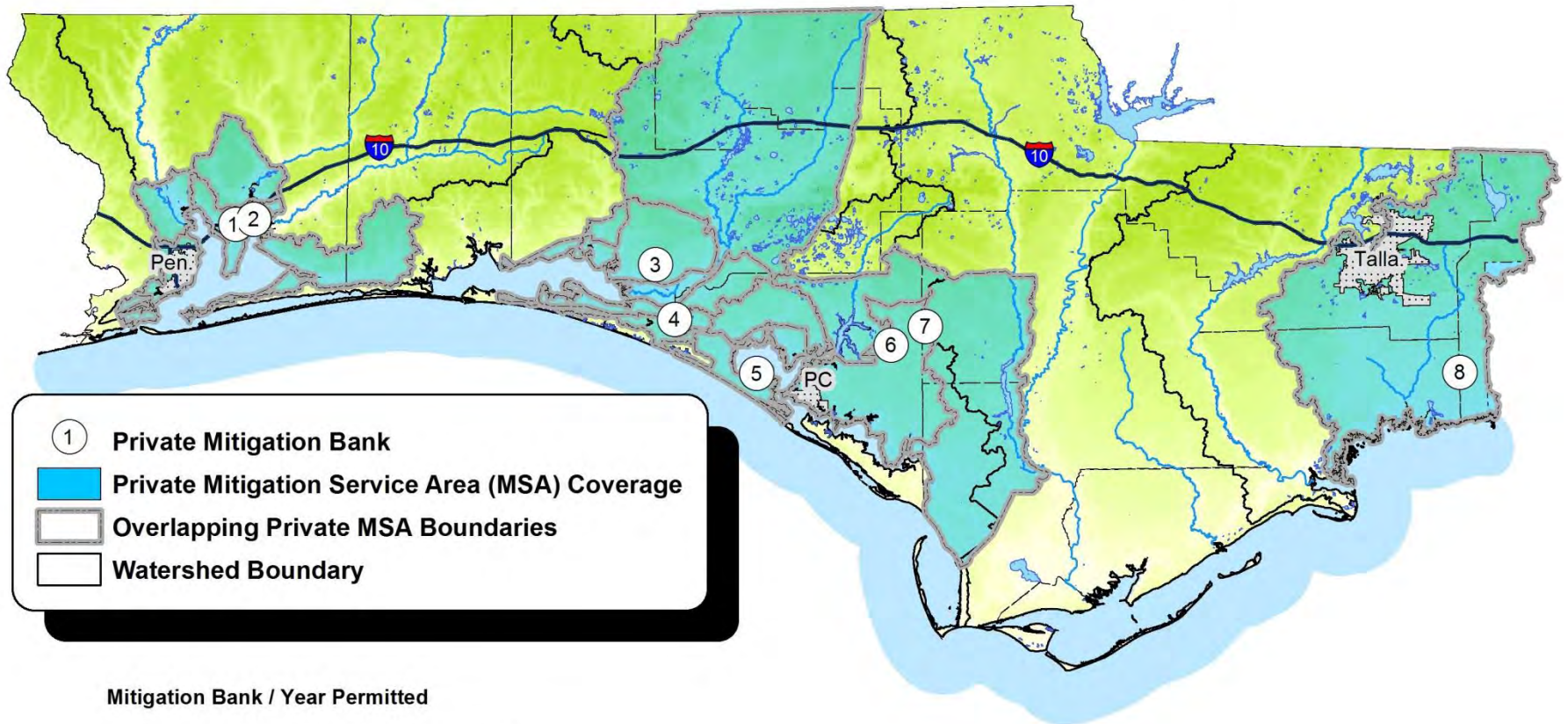
NWFWMD In-Lieu Fee Program Mitigation Sites



NWFWMD In-Lieu Fee Program Mitigation Service Areas



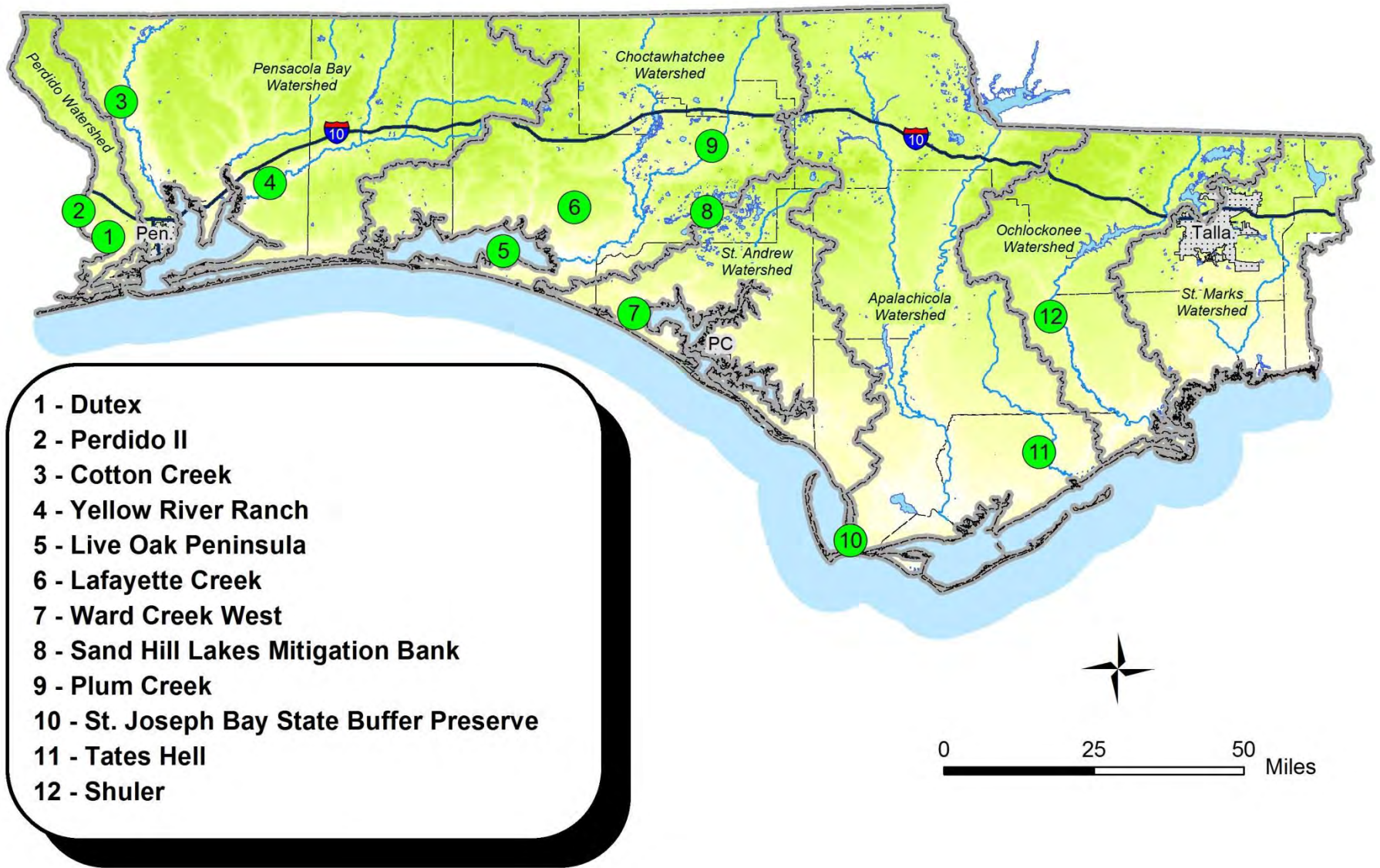
Private Mitigation Banks in Northwest Florida



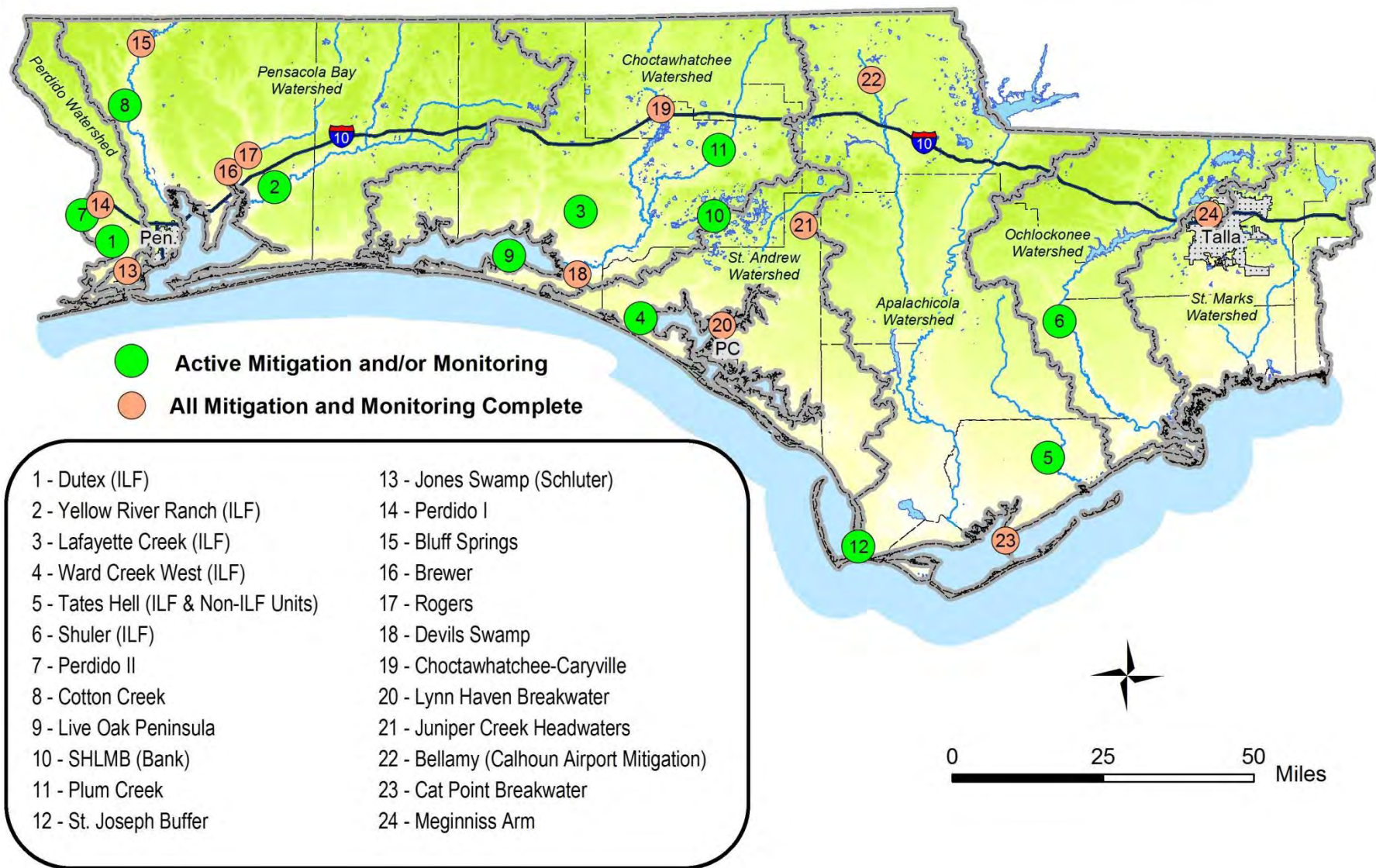
Umbrella Plan (Non-ILF) Projects with Ongoing Restoration Activities



Active Monitoring (ILF and Non-ILF Projects)



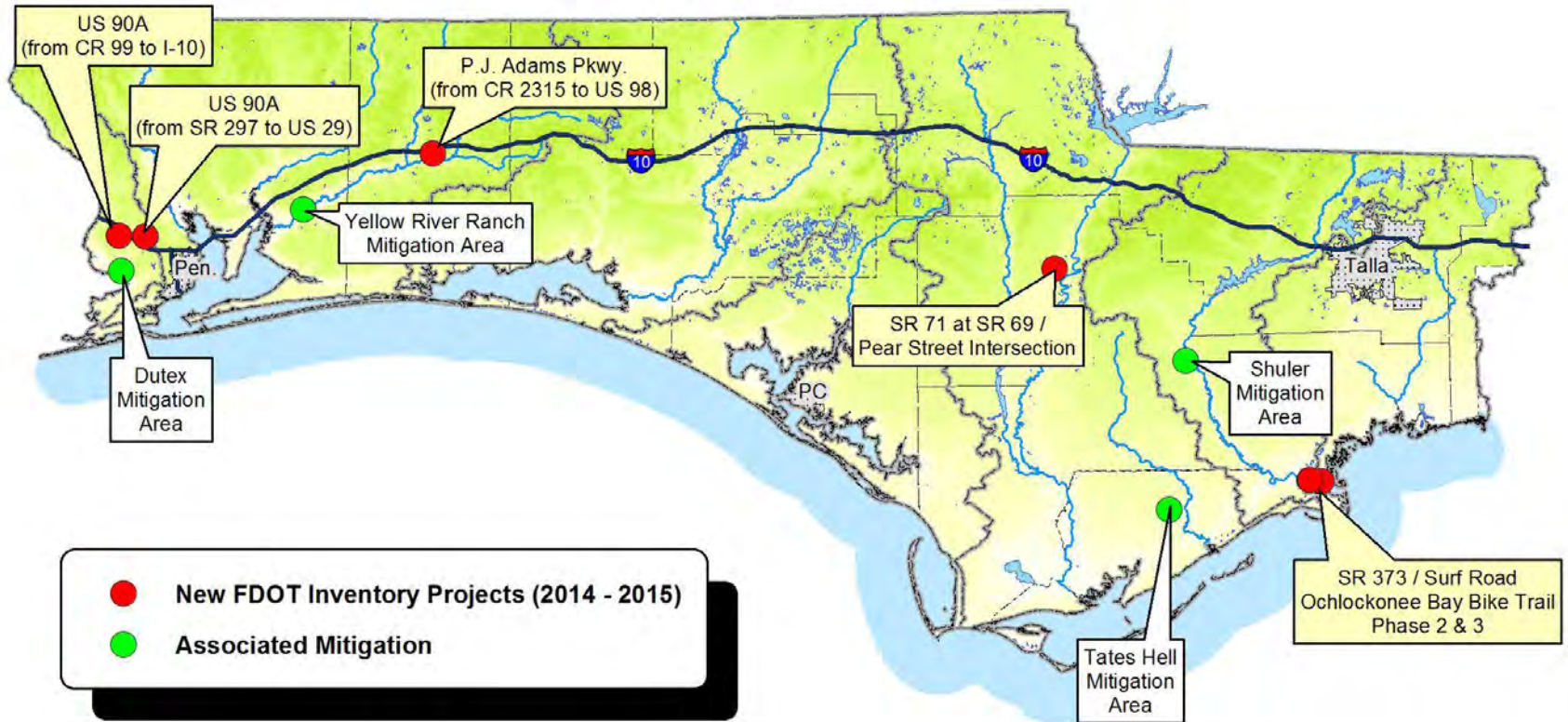
All NFWFMD Mitigation Projects for FDOT Impacts (1997 - 2014)*



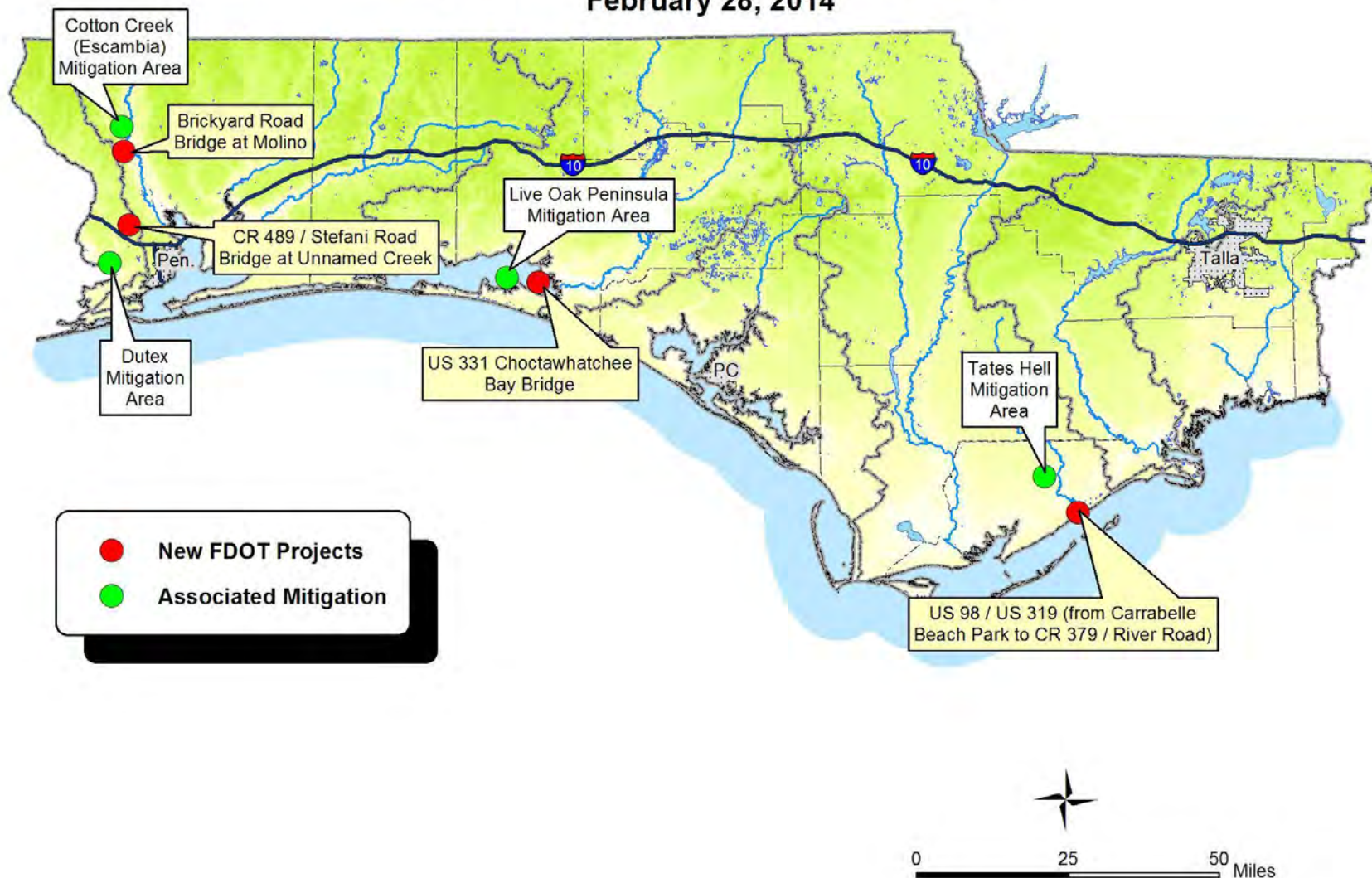
