SUBJECT: Consideration of Resolution No. 793 Amending the Fiscal Year 2014-2015

Budget (Amendments No. 1 and No. 2)

Amendments No. 1 and No. 2 to the Fiscal Year (FY) 2014-2015 District Budget increases the total operating expenditure budget by \$887,287.

Amendment No. 1 requests a \$510,000 increase in spending authority and revenue for enhanced hydrologic and water quality monitoring activities of Wakulla and Jackson Blue Springs. This funding is for a contract between the Northwest Florida Water Management District and the Florida Department of Environmental Protection (DEP), utilizing appropriations in the FY 2014-2015 General Appropriations Act (GAA), Line Item 1642A from the General Revenue Fund.

Amendment No. 2 requests a \$377,287 increase in spending authority and revenue to facilitate the completion of spring bank restoration and protection construction activities at Williford Spring. These activities were scheduled to be performed in late FY 2013-2014, but due to water levels and inclement weather, they have been postponed to FY 2014-2015. This funding is cost reimbursable through an existing agreement with DEP, No. S0676, utilizing appropriations in the FY 2013-2014 GAA, Line Item 1638A from the General Revenue Fund.

### Recommendation

The total fiscal impact of the two amendments is a budget increase of \$887,287 in spending authority and revenue.

Staff recommends that the Governing Board approve Resolution No. 793 amending the Fiscal Year 2014-2015 Budget and allow staff to realign revenues and reserves to maintain the proper balance in each fund.

**WHEREAS**, a budget amendment involves an action that increases or decreases total appropriated Fund amounts in the Budget; and

**WHEREAS**, pursuant to section 120.525, Florida Statutes, the District has provided notice of its intention to amend the Budget in the published notification of the Governing Board meeting at which the amendment will be considered; and

**NOW THEREFORE**, be it resolved by the Governing Board of the District, that:

The Budget is hereby amended as summarized in the memorandum dated November 24, 2014 requesting Amendment No. 1 and Amendment No. 2 to the Fiscal Year 2014-2015 budget.

 Budget Amendment No. 1 provides an increase in spending authority and revenue in the amount of \$510,000 for contractual services and capital outlay enhanced hydrologic and water quality monitoring activities of Wakulla and Jackson Blue Springs.
