Dear Vicki,

The Sand Hill Lakes Mitigation Bank (FDEP Permit 0227351-001) has a current state Credit Ledger balance of 27.47 UMAM Credits (3.23 Freshwater Herbaceous, 8.68 Freshwater Forested Flatwoods, 15.56 Freshwater Mixed Hardwoods).

This letter is a request for withdrawal of a total of 8.78 UMAM credits (8.69 Freshwater Mixed Hardwoods credits and 0.09 Freshwater Herbaceous credits) from the state Credit Ledger to satisfy requirements of three FDEP permits:

- 1.09 Freshwater Mixed Hardwoods credits will be used to offset impacts associated with FDEP Permit No. 67-0286499-001-DF (Sally Cooley), Specific Condition No. 20, issued 8/11/08, (widening of SR 79 from Environmental Road to Strickland Road).
- 7.60 Freshwater Mixed Hardwoods credits will be used to offset impacts associated with FDEP Permit No. 67-0278545-001-DF (Sally Cooley), Specific Condition No. 15, issued 3/13/09 (widening of SR 79 from Strickland Road to Potters Spring Road).
- 0.09 Freshwater Herbaceous credit will be used to offset impacts associated with FDEP Permit No. 03-0294647-001-DF (Sally Cooley), Specific Condition No. 18, issued 4/22/09 (Adler Properties, LLP).

This request is made under the provision of Specific Condition No. 20 of our approved Mitigation Bank Permit. A draft Credit Ledger Update reflecting the requested withdrawal transaction is attached. Corresponding credits will also be debited from the federal credit ledger.
