Recommendation

Staff recommends that the Governing Board approve the bids submitted in response to ITB 16B-007 for Testing and Monitor Well Construction in Santa Rosa, Okaloosa, and Walton Counties, Florida and authorize the Executive Director to enter into an agreement with the qualified bidder that submitted the lowest bid.

Background

On May 5, 2016, the District issued an Invitation to Bid (ITB) 16B-007 for exploratory drilling and well construction services in support of Minimum Aquifer Level (MAL) development along the coast of Santa Rosa, Okaloosa, and Walton counties. Four firms attended the mandatory pre-bid conference on May 24, 2016.

On June 6, 2016, at 2:00 p.m. EDT, the District received two sealed bids in response to this Invitation to Bid. The bids received are listed below for your consideration.

Subsequent to approval by Governing Board, a contract will be negotiated, prepared and executed with the qualified bidder that submitted the lowest bid.
