#### Recommendation:

- 1. Execute Amendment No. 9 to Grant AT003 with the Florida Department of Environmental Protection (DEP) to accept additional funding up to \$750,000 for the July 1, 2024, to June 30, 2025, period.
- 2. Execute agreements with contractors to conduct work associated with Grant AT003 from July 1, 2024, through June 30, 2025, subject to legal counsel review and approval of the District budget for Fiscal Year 2024-25. The cost for this work is not to exceed \$750,000.

#### Discussion:

This request is for approval of an amendment to Grant AT003, which provides funding to continue data collection efforts from July 1, 2024, through June 30, 2025, for the St. Joseph Bay Assessment Project. The St. Joseph Bay Assessment Project involves collection of discharge and water quality data in St. Joseph Bay, the Intracoastal Waterway, the Apalachicola River, Lake Wimico, and St. Andrew Bay to enhance our understanding of flows through the system. Additional efforts anticipated to be completed under this amendment include satellite mapping of water quality patterns around St. Joseph Bay and additional lab analyzed water quality samples. Anticipated funding for the July 1, 2024, to June 30, 2025, period is not to exceed \$750,000.

Protection for Continued Integrated Water Resource Monitoring

#### Recommendation

Staff recommend the Governing Board authorize the Executive Director to execute an agreement or an amendment to the current agreement for continuation of the Integrated Water Resources Monitoring program with a contract amount up to \$150,000 for the period of July 1, 2024, through June 30, 2025.

#### **Background**

The Florida Department of Environmental Protection (DEP) created the Integrated Water Resources Monitoring program in 1996: a multi-resource, comprehensive, integrated program to monitor surface water and groundwater quality. The District has participated in the program since its inception. The large volume of water quality data produced has supported timely, accurate assessment of the quality of the District's water resources. This data is available to the public through DEP's water quality databases.

This contract consists of two projects for the collection of surface water and groundwater quality data from sites across the District.

- The Water Quality Status Project consists of the annual collection of 85 samples from five resource types: confined aquifers, rivers, large lakes, streams, and unconfined aquifers. A new set of random sample sites are selected for each resource every year.
- The Groundwater Quality Temporal Variability Project involves monthly sampling of seven wells and one first magnitude spring at five fixed monitoring locations and is designed to track water quality changes over time.

The Florida Department of Environmental Protection will compensate the District up to \$150,000 for this data collection on a fee schedule/cost reimbursement basis.

#### Recommendation

#### **Background**



#### **Background**

The District was approached by GFBC who desire to donate the fee simple interest in 6.828 acres they own along Choctawhatchee Bay in Walton County in exchange for the release of two small conservation easements on 0.35 acres in Walton County by the Board of Trustees of the Internal Improvement Trust Fund of the State of Florida.



The District will incur the following expenses with this donation.


<u>Environmental Site Assessment</u>. The District will order an environmental site assessment on the property. The cost of the assessment is estimated not to exceed \$3,500.

<u>Title Search</u>. The District ordered and received a title exam and commitment on the GFBC property at a cost not to exceed \$150.

Grayton Forest Business Center, LLC will provide the survey, title policy, and pay all other closing costs.

#### AGREEMENT OF DONATION

This Agreement of Donation ("Agreement") is made this \_\_\_ day of \_\_\_\_\_, 2024, by and between the Northwest Florida Water Management District, a special taxing district of the State of Florida, whose address is 81 Water Management Drive, Havana, Florida 32333 ("District") and Grayton Forest Business Center, LLC ("GFBC"), whose address is 1216 JD Miller Road, Santa Rosa Beach, Florida 32459.

WHEREAS, GFBC is the owner of 6.828 +/- acres in Section 9, Township 2 South, Range 20 West, Walton County, Florida more particularly described in Exhibit A to this Agreement (hereinafter referred to as the "Property") as previously described by a survey prepared by GeoPoint Surveying, Inc.;

WHEREAS, GFBC is desirous of donating the fee simple interest in 6.828 acres to the District; and

WHEREAS, the District is desirous of accepting the 6.828 acres in fee simple as a donation.

NOW THEREFORE the parties agree as follows:

- 1. Recitals. The above recitals are true and correct.
- 2. <u>Donation</u>. GFBC agrees to donate the fee simple interest in 6.828 acres to the District, with all the improvements, easements and appurtenances thereto.
- 3. Documents, Costs and Closing. GFBC shall execute and have recorded the Warranty Deed and closing shall occur on or before the 30th day of September 2024, at the law offices of Matthews & Jones, Attorneys at Law. Each party will be responsible for its own costs for legal representation. The District will pay the cost for an environmental site assessment and title exam. GFBC shall pay for document prep, title policy, recording fees, documentary stamp taxes due on the property and for the cost of recording such other documents as may be required to be recorded to create clear and marketable title for the Property. At closing, GFBC shall execute the Warranty Deed and a Seller's Affidavit more particularly described on this Agreement as Exhibit B. The Property shall remain until closing in the same condition as it exists on the effective date of this Agreement, ordinary wear and tear accepted.
- 4. <u>Title, Survey and Environmental Site Assessment</u>. If the District notifies GFBC of any objection to the title, survey or the environmental site assessment for the Property, then GFBC shall cure such objection prior to closing or the District shall have the right to terminate this Agreement without further liability.
- 5. <u>Inspection</u>. GFBC agrees that after the date of this Agreement, the District and its agents and employees shall have the right upon reasonable notice to enter the Property for all lawful purposes permitted under this agreement.

- 6. <u>Attorneys/Brokers</u>. Each party shall be responsible for its own attorney fees in connection with any actions arising out of this Agreement. Each party warrants to the other that no person or entity is entitled to any real estate commission, finders, referral or any other fee as a result of this Agreement or the subsequent closing.
- 7. <u>Conditions</u>. The District's obligation to perform this Agreement is expressly made contingent and conditioned upon the following:
  - (a) No condemnation proceedings or any other matters which might have an adverse effect on the value of the property shall be pending or threatened against the parcel at closing.
  - (b) The District shall have received and approved the title examination and policy, survey, and the environmental site assessment, provided for herein.
  - (c) There shall be no litigation pending or threatened seeking to recover title to the Property or any part thereof or any interest therein or seeking to enjoin the violation of any law, rules, regulation, restrictive covenants or zoning ordinances that may be applicable to the Property as of closing.
  - (d) The Property or any portion thereof shall not have been and shall not be threatened to be adversely affected in any way as a result of explosion, earthquake, disaster, accident, any action by the United States Government or any governmental authority, flood, embargo, riot, civil disturbance, activity of armed forces or act of God or public enemy.
  - (e) Any and all currently existing liens and/or security interests affecting the Property or any portion thereof shall be fully paid and released at or prior to closing.
  - (f) Release of two conservation easements on .35 acres in Walton County by the Board of Trustees of the Internal Improvement Trust Fund.
  - (g) This Agreement is approved by the Governing Board of the District.
  - (h) All signatories have good and lawful authority to execute this Agreement.

In the event that any one of the foregoing is outstanding or unsatisfied as of the closing, the District shall have the right to terminate this Agreement and neither party shall have any further obligations or liabilities hereunder.

8. <u>Miscellaneous</u>. This Agreement may not be assigned without the written consent of the parties. The legal successor of any party will be bound by this Agreement as fully as that party is bound. This Agreement is the entire agreement of the parties and supersedes all prior and contemporaneous agreements or understandings.

SUBJECT: Consideration of Consultant Selections and Agreements for Mitigation Site

Management and Support

#### Recommendation

Staff recommends the Governing Board approve the selection committee's results provided in Table 1 and authorize the Executive Director to negotiate and execute agreements with Florida Environmental and Land Services, Inc., HGS, LLC dba RES Environmental Operating Company, LLC, and Bio-Tech Consulting, Inc., pending legal counsel review.

#### **Background**

On February 29, 2024, the District issued a Request for Proposals (RFP) for Mitigation Site Management and Support (RFP 24-001). This RFP was issued to provide mitigation site and management support for one or more wetland mitigation and/or restoration sites owned and maintained by the District.

Six (6) proposals were received on March 28, 2024. Of the proposals received, three (3) were determined to be responsive and evaluated by the selection committee using seven (7) predefined selection criteria. The committee's selection scores are provided below in Table 1. The three highest ranked firms are: 1) Florida Environmental and Land Services, Inc., 2) HGS, LLC dba RES Environmental Operating Company, LLC, and 3) Bio-Tech Consulting, Inc.
