Recommendation

Staff recommends the Governing Board adopt Resolution No. 959 amending the Fiscal Year 2024-2025 budget and allow staff to realign revenues and reserves to maintain the proper balance in each fund.

Background

District procedures allow for budget amendments to occur within 60 days following the end of the fiscal year (FY). Based on expenditures paid that count toward the FY 2024-2025 budget, one change is requested to properly align budget with these costs. Amendment No. 3 realigns budget categories of Contracted Services, Operating Capital Outlay, and Fixed Capital Outlay within and between funds and categories. This amendment does not increase or decrease the total District budget.

Budget realignment includes:

1. \$58,000 in budget transfers from Contracted Services to Operating Capital Outlay (\$35,000) and Fixed Capital Outlay (\$23,000) to properly reflect activities performed.






Background


Background


In 2020, the District purchased 131.49 acres from Mr. E. Guy Revell, Jr. in Wakulla County for springs protection, specifically protecting Wakulla Springs. The property is a mosaic of agricultural land with natural upland and wetland forest. The Revell tract is located in the Wakulla/Spring Creek Spring Group Groundwater Contribution Area, Primary Focus Area 2. Mr. Revell owns a residence that is adjacent to the property purchased by the District. Mr. Revell (and the individuals renting the residence) access this residence via an existing driveway located on the now District-owned property approximately 30 feet north of Mr. Revell's property. Before closing on this property in August 2020, District staff requested and received approval from the Governing Board to allow Mr. Revell to retain a 20-foot access easement across the District-owned property, directly adjacent to Mr. Revell's property line, and Mr. Revell would relocate his driveway to within this easement (see attached maps). Today, this easement remains wooded and undeveloped and relocation of the driveway has not occurred largely due to utility boxes on the adjacent property.

After owning and managing this property for the last five years, District staff has recognized that the existing driveway that has continued to be utilized for ingress/egress to access the residential property has not complicated or interfered with the District's public recreation or land management

uses of the 131-acre property. As such, District staff would like to request Governing Board approval to amend the easement for ingress/egress to the boundaries of the existing driveway. Mr. Revell has agreed to pay all expenses, including preparation of the survey sketch and legal description and recording fees.

SUBJECT: Consideration of Three Grant Donations for Reforestation and Habitat

Restoration on District Lands

Recommendation

Staff recommends the Governing Board authorize the Executive Director to: 1) Enter into a reimbursable grant agreement with the Arbor Day Foundation in an amount up to \$72,974 to support District reforestation efforts, 2) Approve a grant donation of up to \$30,000 from The Nature Conservancy to support labor costs associated with District reforestation efforts, and 3) Enter into a reimbursable grant agreement with the National Wild Turkey Federation in an amount up to \$40,000 to support prescribed burning efforts, subject to legal counsel review.

Background

The Arbor Day Foundation provides grant funding for various tree-planting programs throughout the U.S., including the resource restoration efforts at the Northwest Florida Water Management District (NWFWMD).

In 2023, the District applied for and was awarded \$116,984 to plant 550,000 trees within the Apalachicola River, Chipola River, Econfina Creek, and Perdido River Water Management Areas. Subject to approval of this agreement from the Governing Board, this fiscal year's grant award will provide up to \$72,974 for the purchase and installation of 331,000 longleaf pine tubelings within the Apalachicola River and Econfina Creek Water Management Areas. To date, more than 25,000,000 longleaf pine trees have been planted on District lands, and the Arbor Day Foundation has been the most significant financial partner providing the majority of funds towards the purchase of the longleaf pines utilized to restore more than 34,000 acres of District Lands to their native habitat.

As a member of the Apalachicola Regional Stewardship Alliance (ARSA), the NWFWMD regularly receives support and resources from The Nature Conservancy. Upon approval from the Governing Board, this will allow the District to receive a donation of up to \$30,000 towards labor costs associated with tree planting in support of the District's reforestation efforts.

The National Wild Turkey Federation provides grant funding assistance through the Florida Fish & Wildlife Conservation Commission's Wild Turkey Management Program to support wildlife habitat conservation and enhancement projects throughout Florida. Upon approval from the Governing Board, this will allow the District to receive a grant donation of up to \$40,000 towards contract prescribed burning of 914 acres in the Choctawhatchee River WMA. Both projects will provide significant habitat improvement for the wild turkey.

The District's Fiscal Year 2025-2026 budget has funding allocated to support these reimbursement programs. Together, these three grant/donation programs will provide a total of \$142,974 in support of the District's resource restoration efforts.

Recommendation

Staff recommends the Governing Board authorize the release of the regulatory Conservation Easement encumbering approximately 11.04 acres as identified in expired Permit IND-033-17573-1 for The Colonies.

Background

The District issued Environmental Resource Permit IND-033-17573-1 (the "Permit") on March 14, 2017, authorizing the construction of an 87.3-acre single-family subdivision located in Cantonment. This Permit authorized a 0.26-acre wetland impact for a wetland crossing to reach the uplands for residential development. The wetland impacts were authorized to be offset through the preservation of onsite wetlands and an uplands buffer. On March 21, 2017, a Conservation Easement was recorded to preserve the remaining approximately 11.04 acres of wetlands and upland buffers on site. The property was never developed under this Permit and the Permit expired on March 14, 2022. On September 26, 2025, a Conceptual Environmental Resource Permit application CON-033-326699-1 was submitted for the site including a request for revocation of the Conservation Easement to allow for a different design as required by Escambia County. District management and staff have determined the release of the Conservation Easement is logical. Any future environmental resource permits issued on the property will include the review and approval of wetland impacts and the mitigation of impacts. Future environmental resource permits will be conditioned accordingly which may include wetland preservation.

for the Pilot Distributed Wastewater Grant Program

Recommendation

Staff recommends the Governing Board (1) approve the Santa Rosa County Distributed Wastewater Treatment System project for up to \$1,000,000, (2) approve the Washington County Distributed Wastewater Treatment System project for up to \$1,000,000, and (3) authorize the Executive Director to enter into agreements with Santa Rosa County and Washington County for up to the amounts identified to implement the projects, subject to legal counsel review.

Discussion

The FY 2023-24 General Appropriations Act included \$2,000,000 for the District to implement a Wastewater Treatment Systems Grant Program, specifically for distributed wastewater systems in areas with waterbodies not meeting water quality standards. The grant program was developed as a pilot program so that monitoring data and cost-effectiveness of different treatment systems can be collected and evaluated.

The District previously entered into a contract with Gulf County for a Distributed Wastewater Treatment System program project on July 15, 2024. On June 5, 2025, the District received a letter of grant termination from Gulf County because the project was deemed not optimal or cost effective due to the high groundwater table in the project area of Indian Pass.

The District re-solicited for grant applications for the program from July 21, 2025 through September 22, 2025. Two applications were received, one from Santa Rosa County and the second from Washington County. The Santa Rosa County Distributed Wastewater Treatment System (DWTS) project will eliminate up to 50 septic tanks north and east of Blackwater Bay outside of the City of Milton's franchise area with an estimated nutrient reduction of up to 362 lbs/year. The Washington County DWTS project will eliminate up to 32 septic tanks and/or new construction hook-ups in the central Washington County area in the vicinity of Flat Creek, Holmes Creek, and the Choctawhatchee River with an estimated nutrient reduction of up to 222 lbs/year.

The grants will provide for a phased implementation approach to ensure timely project completion. The first phase will include public outreach, verification of adequate homeowner participation and

documentation of the required minimal separation of 12 inches of the seasonal high groundwater table from land surface. Dependent on the successful completion of the first phase, the second phase will include design, permitting, construction of the new treatment systems, removal of septic tanks, development and implementation of a monitoring plan to evaluate pollutant reductions pre- and post-project, and an operational cost incentive toward expenses while the project is under construction. The projects are estimated to take 24 months to complete.

Blackwater Bay is an impaired water body for bacteria and nutrients. Flat Creek is an impaired water body for bacteria. Holmes Creek and the Choctawhatchee River are impaired waterbodies for nutrients.

Washington County is a rural and economically distressed county pursuant to s. 288.0656, F.S. and is requesting a waiver of match funding requirements for the project.

The lawsuit styled **Northwest Florida Water Management District v. Kenneth Sadler and Mildred Sadler, husband and wife,** continues to be litigated in the Circuit Court in and for Washington County, Florida. The lawsuit alleges continuing trespass and ejectment for the Sadlers' placement and construction of, and failure to remove, certain improvements upon District-owned land. The Washington County Sheriff's Office served the complaint on the Sadlers. The Sadlers did not timely respond to the complaint.

After waiting more than sufficient time to allow for a response from the Sadlers to be filed, the District moved for default judgment. In the interim, the Sadlers filed a letter with the Court, which the Court deemed a response to the complaint and declined to enter a default judgment.

Subsequently, the District has propounded written discovery to the Sadlers. The Sadlers have not responded to the District's discovery requests within the required time period. The District will now file a motion to deem its requests for admissions as admitted and follow that with a motion for summary judgment to require the Sadlers to remove the improvements from District-owned land.
